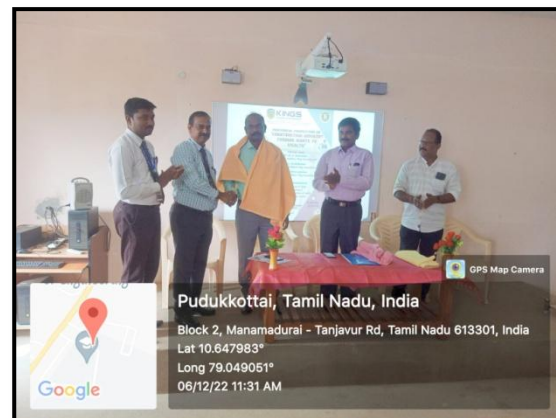

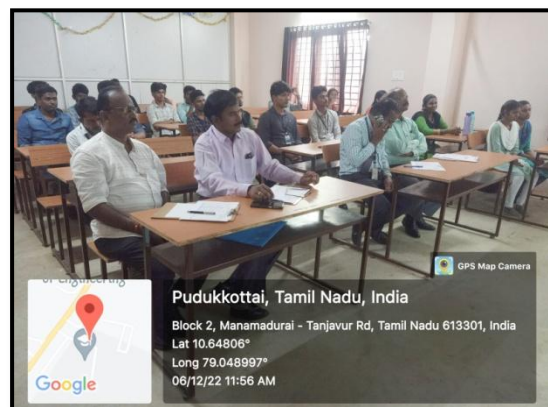
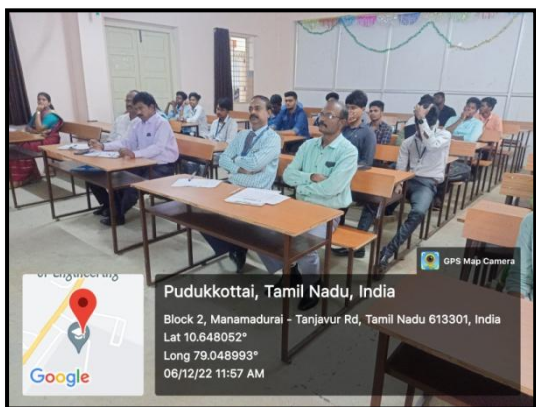


PRESENTATION SESSION

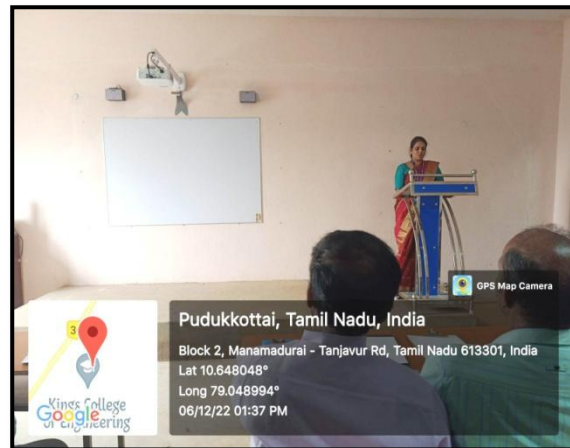
